TOURNAMENT PLAYING RULES AND REGULATIONS

1. All entrants may cash only once with the same partner, but you may enter multiple times.
2. All Team Captains must check-in lineups at least 15 minutes prior to the start of their selected shift.
3. Highest USBC sanctioned average of the previous season based on 21 games or more must be used.
4. When a previous season's average is used and at the time of entry and entrant has a current season average with 21 or more games and that average is 10 or more pins above last season's average, current seasons average must be used.
5. Averages established in a Summer league will not be acceptable. Summer leagues are defined as leagues that have a start date after March 15th for the Summer season only
6. A bowler who has no 21 game minimum average for the previous season must use the highest current season's average as of March 1, 2019 with a minimum of 21 games. If no average meets any of the criteria as described above, an average of 220 must be used.
7. Handicap will be 100% of 220 per person. Handicap will be on an individual basis. Handicap on averages above 220 will be 0.
8. Maximum handicap is unlimited.
9. Report all substitutions to the Tournament Manager 30 minutes prior to the start of your shift.
10. Prize ratio – there shall be at least one prize in every 8 entries.
11. All USBC rules apply when not addressed elsewhere on this entry.
12. In case of protest, please notify the Tournament Manager immediately.
13. A complete prize list will be posted at all Association establishments and at www.dunkirkakeshoreusbc.com.
14. All checks for entry fees may be made payable to : DLBA
15. Prize fees are 100% returned. Entry fees must accompany entry.
16. All averages must be attested by the Team Captain and is responsible for their accuracy.
17. It is the bowler's responsibility to submit average adjustments (per rule 4-6 above) prior to the start of your shift.
18. Each entrant must be prepared to produce their individual USBC membership card prior to bowling.
19. Entries open only to current members of the Dunkirk Lakeshore Bowling Association. You cannot buy a sanction to enter this event.
